TERMS OF REGISTRATION

Application Deadline: 15th March 2015

General Information

The OpenEyes Filmfest is an independent filmfestival that is organized by the socio-cultural centre Café Trauma e.V. There is no limitation of topics. Films of every possible genre are welcome. Classification assigned to the festival in general is 18/NC-17.

Selection of Films

All films submitted are viewed and selected by independent jurys, who are also responsible for the programm. Official selection will be published by 15th June 2015.

Winners

It is the OpenEyes filmfestival's audience that selects one winner and two runner-ups in every category (feature film, documentary, experimental film/music video, animation).

Application Requirements

The following requirements must be met by every film submitted:

- a. RUN TIME: 30minutes maxb. PRODUKTION: from 2012
- c. VIEWING COPY: DVD, Blu-ray Disc, AVI
- **d.** PROJECTION COPY: DVD, Blu-ray Disc, AVI Different types of projection copies are only possible after consultation with the OpenEyes Team.
- e. SYSTEM: PAL
- **f.** LANGUAGE/SUBTITLES: Dialogue should be in German or English, if not, German or English subtitles must be provided.
- **g.** DEADLINE FOR PROJECTION COPIES: 1st July 2015. Copies delivered after the deadline might not be considered. In this case, the OpenEyes Team will use the viewing copy for projection.
- h. The team is permitted to take stills. In the event that only the transmitted stills should be used, the sender will apply a note.

Category of Film

Every film can only be submitted in one category. Thereby, the chosen category is the same as the category in which the film will be judged. The viewing-jury reserves the right to adapt the category.

Viewing and Projection Copies

- a. Viewing copies are not returned to the sender. Viewing copies will remain in the hands of the OpenEyes, which is entitled to show the film in follow-up events of the OpenEyes Festival.
- **b.** The sender is responsible for the delivery of the projection copy. This includes all shipment fees. Projection copies will be returned as a parcel at the expense of Café Trauma e.V.
- **c.** Projection copies are insured for the duration of the OpenEyes Filmfest by Café Trauma e.V.
- **d.** Café Trauma e.V. cannot be held responsible for projection copies that are damaged during the return.
- e. Complaints for damaged copies can only be filed up to seven days after receiving the return.
- f. Shipments from non-EU countries must be declared as:

Temporary import For cultural purposes only. No commercial value

g. Projection copies which have not been delivered until 1st July 2015 might not be considered to run at the festival. In this case, the sender will be charged for the return.
